

Register of interests for Primary Advantage Federation governors 2019-20

The decision-making processes of the federation should be conducted, and seen to be conducted, in an objective and unbiased manner. Governors, local advisory board members and school staff have a responsibility to avoid any conflict between business and personal interests and the interests of the federation or its schools. To help put this duty into practice and to meet legal requirements, all schools maintain a register of pecuniary (financial) and business interests. The register will ensure that governors', LAB members' and staff members' personal interests do not unfairly prejudice, influence or conflict with the decision-making processes of the federation or its schools.

While the federation is not required to do so, it considers it is best practice to publish the interests of all budget-holding members of staff.

The federation is also required to publish the date its governors were appointed and the length of their term of office.
